

Eligibility & Participation

Children eligible for admission are dependent children ranging in age from six weeks to five years of age of Wounded Warriors, active duty military personnel, DoD civilian personnel paid with either APF or NAF, reservists/guard on orders, mobilized Guard/Reserve on orders, surviving spouse combat related, DoD Contractors, Federal Retirees, and inactive/guard reserve. Register for care on Military Childcare.com. Care is offered based on a priority system.

Types of Care

Full Time Care

All enrolled children are considered full-time. Your space is for you to use during our regular open hours.

Hourly Care

Hourly care is available on a space available basis. The cost of hourly care is \$7.00 per hour or any part of an hour per child. Reservations are for times between the hours of 0630-1730. Payment for hourly care is due upon pick up of your child.

Leased Care

Parents have the option to lease their child's slot to other eligible patrons. When a child will not be in attendance for the week, the parent can coordinate with other parents to lease the slot. The lessee will provide the appropriate paperwork in order to determine their eligibility and fee category. The slot owner is responsible for payment if the agreement falls through.

Fees for full time care are on a sliding fee schedule with thirteen categories based on Total Family Income. To estimate your fees please use the chart below. Proof of your family's Total Family Income (active duty current LES and/or civilian pay statement) will be required upon enrolment. If you have more than one child, the older child(ren) will receive a 10% discount.
